First, they grouped on finding one, three, and seven: the topic covered service awareness and navigation, social connection, mental health, and caregiver resources. Then, for findings two and six, they discussed BIPOC and LGBTQ+ people, including adults with disabilities in their groups. Additionally, they deliberated the suggestions for implementation and the priorities for those suggestions. They will talk more in the October 17 meeting.
